## Aims of the course:

To get students acquainted with basic topics and contemporary ideas in social sciences at the levels of theory and epistemology, then methodology and empirical researches, and finally as practical and applied social science.

## **Course result:**

Students will get direct insight into empirical evidence that confirm relevance of the issues covered by the sociology of law but also legal theory in general. This will enable comprehending the importance of the legal profession, development of legal consciousness and understanding of the development of law as a technique to regulate relations in a society. Students will be able to develop critical stance towards their own profession and critically reflect law.

III SOCIAL GROUPS AND LAW - Social structure and legal system, The concept of social groups and types of social groups, Contemporary marriage, family and family law, Social and legal aspects of gender issues, Ethnic relations and law, The rights of local communities, Social inequalities and law. IV SOCIAL INSTITUTIONS, ORGANIZATIONS AND LAW - Social institutions and organizations as foundations of social and legal system, Types of social institutions and organizations, Law and bureaucracy, Organization of "total" and "disciplinary" institutions, Autocratic and democratic organizations, Political organizations and law. V CULTURE AND LAW – The concept of culture and its elements - pluralism of cultural patterns, Law as a cultural pattern: from customs to law, Legal culture as unity of legal consciousness and practice, Forms of culture and law, Professions and professional ethnics, Ideology and law, Social control and deviance VI CHANGES IN CONTEMPORARY SOCIETY AND LAW Changes are constant, but development and progress are not, Law as a factor and indicator of social development, Right to education and development of contemporary societies, Communication technologies and the law of information society, Law, force and globalization: "world society" and/or "new world order", Social risks and legal challenges of globalization, Serbia - legal state in European integrations.
