<b>Aims of the course:</b>			
The aim of the course is to provide students with deepened knowledge of foreign investment rights and enable them to apply acquired knowledge in scientific research. The emphasis is on critical approach to existing legal and comparative solutions, theoretical concepts and judicial and arbitration practice.			
<b>Course result:</b>			
The course provides students with deeper knowledge in the field of foreign investment rights, which includes the basic institutions of foreign investment rights, foreign investment standards, foreign investment issues, and the issue of foreign investment disputes. The specific choice of topics to be processed depends on the subjects of the scientific research work of the applicants. The complexity and diversity of the subject matter requires a combination of methodological approaches in the treatment of topics, so that in addition to classical lectures, interactive forms of work (seminars) are also necessary, which give the opportunity to further study certain topics with a greater self-engagement of the participants.
