Aims of the course: The aim of this course is to enable candidates to broaden and deepen their knowledge of administrative law.
Course result: Candidates should acquire knowledge and skills enabling them to critically approach complex questions of administrative law and to conduct independent research in this area.
Course content: Current issues of administrative law and, in particular: I. Controversies regarding different theoretical concepts of the notion “administration” (Functional and organizational concepts of the administration. Administration as administrative power. Administration as public service.); II. Administration in the separation of powers system (Administration and the Legislature. Administration and the Judiciary. Legality and legitimacy of administrative action); III. Administrative Law as a legal discipline (Broad concept of the subject matter of Administrative Law. Narrow concept of the subject matter of Administrative Law. Administrative law and social regulation). IV. The Administrative act (Notion and types of acts of the administration. Types and features of administrative acts). V. Principles of administrative procedure (General and special administrative procedures); VI. Control of the administration (Administrative dispute. The Ombudsman); VII. E-Government (E-Administration).
