Aims of the course: Learning about special named contracts of the law of obligations and succession law, comparison with relevant judicial acts in comparative law (part of the French civil law known as les libéralités), analysis of proposed solutions in the Draft Civil Code of the Republic of Serbia about the reintroduction of succession contracts in Serbian positive law and the limitation of the possibility of concluding life care contracts.			
Course result: Enabling students to understand the advantages and disadvantages of special named contracts and succession law contracts in scientific and practical work, familiarization with possible new solutions in the Civil Code of the Republic in Serbia, which is being drafted.
